PAYMENT PLANS

There are four payment plans to choose from:

PLAN B Requires a 25% deposit with contract. The balance is due in three equal payments: July 10, August 10, and September 10, 2010. You will be billed at the beginning of each month.

PLAN C Requires a 10% deposit with contract. There is no additional interest, but in order to qualify for this plan you must provide a credit card. The balance is due in nine equal payments beginning July 10, 2010 with the last payment due March 10, 2011. You will be billed at the beginning of each month. If payment is not received by the 26th of the month, Workbook is authorized to charge your credit card.

PLAN D Requires a 25% deposit with contract. A 10% space discount is available to those who send the balance of their payment to the Workbook office postmarked by June 11, 2010. No invoice will be sent. There are no exceptions.

PLAN E A 5% space discount is available for full payment with contract.
